6. County Elections and Banking Update

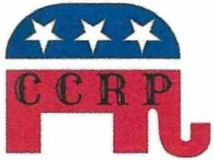
Chairman Metevier reviewed the March County Party elections. Chairman Metevier reviewed what the Bank of Commerce requires to make the necessary changes for the bank account.
