

**Resolution from the Central Committee of the Carbon County, Wyoming Republican Party.
ENDORSEMENT OF LEGISLATIVE LEADERSHIP CANDIDATES**

Passed by the Carbon County, Wyoming Republican Party on Oct 30, 2024 and submitted to the State Central Committee of the Wyoming Republican Party for consideration and adoption.
